- 3. The candidate has never been prohibited from professional activity in any entity which is regulated and supervised by QFMA under Article 35 paragraph 12 of Law No. 8 of 2012.
- 4. The candidate shall not be a member of the board of directors of more than two (2) Qatari shareholding companies.
- 5. The candidate shall not be a member of the board of directors or senior management of a company engaged in business activities similar to the Company.
- 6. The candidate shall be subject to the Fit and Proper Criteria for the nomination of directors pursuant to Annex 1 of CGC.
